- Children and Learning (C&L) responsible for teaching and learning matters including target setting, standards and achievement, SEN (including reporting annually on the success of the SEN policy), behaviour, safeguarding, attendance, children's spiritual moral social and cultural development, children, parent and staff voice, extra-curricular activities, cluster and other partnerships. Committee chair: Steven Hilton-Pass
- Pay Review committee responsible for ensuring the implementation of the school Pay Policy and Teacher Appraisal Policy (part of Business & Resources Committee).
- Pay Appeal committee responsible for hearing pay appeals and ensuring a fair and proper process has been followed.
